## 1. PURPOSE

Ball & Doggett is committed to responsible environmental stewardship, regulatory compliance, and transparent supply chains across the print, paper, packaging, labels, visual media, and industrial markets we serve.

We operate in alignment with our SUSTAIN: 2030 and Beyond ESG Strategy, focusing on responsible sourcing, climate impact reduction, and continuous improvement in environmental performance.

## 2. SCOPE

This statement applies to all Ball & Doggett Pty Ltd operations within Australia, including all business divisions, employees, contractors, and suppliers involved in the procurement, distribution, and supply of paper, packaging, labels, visual media, and industrial products.

## 3. COMMITMENT

We are committed to full compliance with all applicable environmental, product stewardship, and chemical management laws and regulations in Australia, including (where relevant):

- Illegal Logging Prohibition Act 2012
- Industrial Chemicals Environmental Management Standard (IChEMS), including PFAS controls
- Relevant state and territory environmental protection legislation.

This commitment is supported through recognised certification and traceability mechanisms, supplier due diligence and risk assessment processes, regulatory compliance controls, and ongoing efforts to manage emissions, resources, and material impacts across operations and the supply chain.
